Overview of conceptual units that represent the basis for hate speech.

3.) Antisemitism from Antiquity to Modern times

Definition of (verbal) antisemitism: Antisemitism as a "cultural code" (Volkov), as "a mental system of belief and of interpretation of the world has been passed down through the centuries, always adapted to current conditions and correspondingly modified, yet without changes in the underlying conceptual constants, according to which Jews categorically function as THE OTHER." (Manichaeism)

4.) Communicative Strategies for construing "the Enemy": historical Antisemitism in Medieval times

Characteristics of anti-Judaism/religious antisemitism Common words, esp. metaphors representing antisemitic stereotypes, strategies of demonization and dehumanization.

5.) Communicative Strategies in racial and especially Nazi Antisemitism

9.) Israel-related antisemitism

Characteristics of the "new" antisemitism, "communicative detour", transfer of stereotypes onto the Jewish state.

Differentiation between Israel-related antisemitism and criticism of Israel.

10.) Latent communication in Post-war Germany, secondary antisemitism

Implicit Radicalism: Implicatures and the Power of Subtlety on the example of implicit Holocaust Denial and Relativization.

New/adapted forms of antisemitic hate speech for avoiding sanctions in German mainstream discourse.
