Yehudah Barlev is Managing Partner and founder of Barlev Associates, Accountants – Investigative Auditing. Barlev worked for various enforcement agencies in and out of Israel, on a variety of investigative audits (e.g., forensic accounting – prevention, detection and quantification of corruption, fraud, money laundering and terror finance) of white-collar offenses on a national and global scale in various countries and in civil disputes. Among his substantial projects were the recovery of the properties of Holocaust victims on behalf of the Knesset's investigation commission and later also for the Governmental Company for Locating and Recovery of Holocaust Victims' Properties;

investigation of the fraud and collapse of the "Commerce Bank"; and delicate projects for foreign governments including economic soft power.

Barlev lectures in various academic institutions in Israeli and in international conventions on investigative auditing issues, economic crime, corruption, money laundering and terror financing, in addition to government officials, regulators, litigators, accountants, bankers, risk and money laundering compliance officers and law enforcement officers. He is also the author of the books, *The Foundations of Investigative Auditing, Par Value* and *Etty, Bernie and the Fraudsters*, in addition to dozens of articles in investigative auditing issues, including on fraud, money laundering and terror finance.

Brown is Assistant Professor at North Carolina Central University (NCCU) School of Law, where he teaches "Legal Reasoning and Writing," "International Law Writing Seminar" and "Civil Procedure and Critical Thinking." He is also the Co-Director of the Social Justice and Racial Equity Institute. His research focus is Pan-Africanism and international law. Brown recently published an article in the *Minnesota Journal of International Law* entitled "Establishing an Integrated Judiciary to Facilitate the African Continental Free Trade Area."

He previously served as the NCCU Prelaw Advisor and Director of the University Honors Program. Prior to entering academia, Brown served as policy counsel at

both the North Carolina Institute of Minority Economic Development and the Center for Responsible Lending, where he advocated for consumer protection laws aimed at reducing predatory subprime lending and rising student debt.

Brown earned his JD from Harvard Law School and his BS from North Carolina Central University. While a law student, he received the Dean of Students Community Leadership Award for his role in co-founding the Harvard Alliance for Israel. Michal Cotler-Wunsh is a prominent public speaker, researcher and independent policy and strategy advisor on intersecting issues of antisemitism, law, human rights and Zionism.

Cotler-Wunsh's focus on process, transparency and accountability continues to inform and guide her in her role as Israel's Special Envoy for Combatting Antisemitism, engaging local and global partners around the shared responsibility to comprehensively identify and address the rise and mainstreaming of ever-mutating antisemitic hate.

Cotler-Wunsh was a Member of Israel's 23rd Knesset. She served as Chair of the Special Committee on Drug and Alcohol Use, Chair of the Subcommittee on

Israel-Diaspora Relations and as active member of several prestigious committees including the Foreign Affairs and Security Committee, Constitution, Law and Justice Committee and the Children's Rights, Women's Status and Immigration and Integration Committees.

She served as the first Knesset Liaison to the Issue of the International Criminal Court (ICC), was co-chair of the Canada-Israel Interparliamentary Friendship Group, was a member of several interparliamentary working groups and Chair of the Caucus for Ethiopians in Israel. Cotler-Wunsh co-founded the Interparliamentary Task Force to Combat Online Antisemitism together with multi-partisan elected officials from Canada, Australia, the US and the UK.

Cotler-Wunsh was born in Israel and grew up in Canada. She received her LLB from the Hebrew University of Jerusalem and her LLM from McGill University in Montreal, Canada. She now lives in Ra'anana, Israel with her husband and their four children.

R. Amy Elman is Professor of Political Science and the William Weber Chair of Social Science at Kalamazoo College in Michigan. She graduated from Brandeis University with a BA and went on to receive a MA and PhD in Comparative Politics at New York University. She has received numerous awards for her scholarship, including two Fulbright grants, a fellowship from the National Endowment for the Humanities and a grant from the Sassoon International Center for the Study of Antisemitism at the Hebrew University.

Elman has worked on behalf of women's rights and against antisemitism in the US and within Europe for over three

decades. She has lectured and published widely on the response of states and the EU to issues of citizenship, migration, violence against women, sex discrimination and antisemitism. She has published four books. Her most recent book, *The European Union, Antisemitism and the Politics of Denial* (University of Nebraska Press, 2014), explores the conditions that precipitated the EU's efforts to stem antisemitism and considers the consequences.

Aaron David Fruh is an ISGAP Research Fellow and the President of Israel Team Advocates International, a non-profit organization that advocates for Jewish existence. Israel Team engages with professors and students on Christian college campuses, pushing back against the growing narrative of anti-Zionism, anti-Judaism, and Antisemitism within the Christian academy. Aaron received an MA from Wheaton College in Wheaton, Illinois. He is the author of four books and the editor of The Casualty of Contempt: The Alarming Rise of Antisemitism and What Can Be Done to Stop It. Aaron writes for The Times of Israel, the Jerusalem Post, The Algemeiner, and Israel365 News.

Aaron's area of research is the history of Christian Antisemitism, with a particular emphasis on Replacement

Theology and Supersessionism. His presentations at the annual ISGAP-Oxford Summer Institute include "From Roots to Branches: Christian Antisemitism" (2022) and "An Examination of the Anti-Judaism and Antisemitism Woven Into the Fabric of Contemporary Christian Nationalism in the US" (2023). Aaron was also co-instructor for ISGAP's Digital Research Center in the spring of 2023: "The History of Christian Antisemitism: Toward a Redemptive Reconciliation."

David Harris is the Vice-Chair of Global Affairs at ISGAP. He served as CEO of the American Jewish Committee (AJC) from 1990 to 2022. The organization was described by the *New York Times* as "the dean of American Jewish organizations," and by French President Nicolas Sarkozy as "the most effective, influential, and respected American Jewish organization."

Harris was referred to by the late Israeli President and Nobel Laureate Shimon Peres as "the foreign minister of the Jewish people." He is the most decorated Jewish organizational leader in US history and is the recipient of four honorary doctorates, including most recently from Brandeis University in 2022.

Harris played a pivotal role in shaping critical global issues—from the rescue of Ethiopian Jewry and Soviet Jewry (including two detentions by Soviet authorities) to helping expand Israel's diplomatic footprint throughout the world. Harris has been committed to preserving Holocaust memory, exploring new relationships in the Arab and larger Muslim world, supporting an end to communism in Eastern Europe, advocating for NATO expansion, combating global antisemitism and promoting interfaith dialogue and understanding.

Harris received his education at the University of Pennsylvania and London School of Economics. He also served as a Visiting Scholar at Johns Hopkins University and both a Junior and Senior Associate at Oxford University. He is the son of two Holocaust survivors and a dedicated husband, father and grandfather.



#### David Hirsh – hirshd@gmail.com

David Hirsh has pioneered a sociological account of contemporary antizionism and its relationship to antisemitism. He has worked on crimes against humanity, totalitarianism, democracy and populism. He teaches core sociology, criminology, crimes against humanity and human rights courses at the undergraduate and master's level. Hirsch is a Senior Lecturer at Goldsmiths, University of London.

He was central in building the Engage network and website that led opposition to the proposal for an academic boycott of Israel from 2004 and that led the fight against antisemitic politics in Britain, especially on

campus. Hirsh was a leading critic of the ideas underpinning the Corbyn movement and he has been instrumental in shaping the democratic and Jewish responses in Britain, and further afield, to antisemitism. He has a global reputation as a scholar and as leader of the fight against antisemitism. He has appeared as an expert witness in a number of court cases and inquiries. He has written formal reports and chaired a university academic appeals panel on antisemitism.

Daniella Kahane is a Peabody award-winning filmmaker and content creator/producer who has collaborated with major brands such as Chevrolet, Honda, Ro and HBO. Her films have been featured and have won awards at top film festivals including Sundance, Tribeca, Toronto, Telluride, SXSW and many others. Alongside her film career, Kahane co-founded WIN (Women in Negotiation), and serves as CEO, expanding it from a once-a-year summit to a year-round operation. Naya Lekht is a scholar on contemporary antisemitism and works with the Jewish community to foster pride in the history of the Jewish people. Lekht received her PhD in Russian Literature from UCLA, where she wrote her dissertation on Holocaust literature in the Soviet Union. In 2018, she was a Scholar-in-Residence at Oxford University through the Institute for the Study of Global Antisemitism (ISGAP).

Lekht is currently teaching Zionism, the history of antisemitism, and working on her book, tentatively titled Zionism in the Diaspora: Reclaiming Israel Education.




#### Dan Michman - Dan.Michman@biu.ac.il


Analysis (2022); and, Jewish Solidarity: The Ideal and the Reality in the Turmoil of the Shoah (2022).

Patterson has lectured at universities on six continents and throughout the US. A winner of the National Jewish Book Award, the Koret Jewish Book Award, the Hadassah Myrtle Wreath Award, and the Holocaust Scholars' Conference Eternal Flame Award, he has published more than 40 books and more than 250 articles, essays, and book chapters on antisemitism, the Holocaust and Jewish studies. His most recent books are *Twenty-Six Questions along the Path to Wisdom* (forthcoming), *Eighteen Words to Sustain a Life* (2023), *Judaism*, *Antisemitism*, *Holocaust: Making the Connections* (Cambridge, 2022), *Shoah and Torah* (Routledge, 2022) and *Portraits: Elie Wiesel's Hasidic Legacy* (SUNY, 2021).

Professor Uzi Rabi, PhD (Tel Aviv University, 2000), is the Head of The Program for Regional Cooperation at the Moshe Dayan Center for Middle Eastern and African Studies and a senior researcher at the Center for Iranian Studies at Tel Aviv University. National Anglo-Jewish Heritage Trail, and a professional Heritage consultant, working nationally and in Europe with religious and minority cultural heritage and religious buildings. He is a qualified teacher who has also worked as a professional tour-guide and run his own heritage tour business in Oxford for nearly ten years.

Involved in the study of Anglo-Jewish heritage, history and archaeology for the past three decades, Roberts has conducted intensive original research into more than 40 Jewish communities across the UK. He also made a documentary film, *Les Chemin des Juifs*, on the Holocaust in NW France and set up the Lincoln section for the Simon Scharma documentary series, *The Story of the Jews*. A trustee and member of Council for the Jewish Historical Society of England, he has written over

35 Jewish heritage trails and personally led many tours, starting with the Oxford trail in 1989.

As well as rediscovering the site and remains of Northampton's medieval Jewish cemetery and synagogue and Jewish Quarter, Roberts helped re-identify England's only example of a medieval Jewish tombstone as well as other archeological remains. He has conducted over a decade of research into the Holocaust on Alderney in the Channel Islands and campaigned for the preservation of Holocaust Jewish graves from a major infrastructure project.

Previously, he was a Bigelow Fellow and Lecturer in Law at the University of Chicago Law School. His research focuses on the First Amendment, anti-discrimination law, and law and religion. His scholarship has or will appear in Columbia Law Review, Cornell Law Review, the Journal of Law and Religion, Columbia Law Review Forum, Yale Law Journal Forum, and several other academic publications, and has been featured in The New York Times, The Washington Post, The New Yorker, and the New York Review of Books. His writing for popular audiences has appeared in The Atlantic, the Los Angeles Times, The Guardian, and the Los Angeles Review of Books. In 2023, the Law and

Religion Section of the Association of American Law Schools awarded Zalman the Harold Berman Award for Excellence in Scholarship.

Before becoming a Bigelow Fellow, Zalman served as a law clerk to Judge Jane Roth on the US Court of Appeals for the Third Circuit and practiced law for several years as a litigation associate at Paul, Weiss. During that time, Zalman was recognized by The American Lawyer in its "Litigator of the Week" profile for winning a Fourth Amendment appeal and securing the reversal of all convictions of his client (2021) and received the "On the Rise—Top 40 Young Lawyer" award from the American Bar Association (2022).

Zalman holds a JD, magna cum laude, from Harvard Law School and a PhD in Religion from New York University.

He serves as the Executive Director of the Bronfman Center for Jewish Student Life at New York University and University Chaplain. Sarna was the inaugural Chief Rabbi of the Moses Ben Maimon Synagogue of the Abrahamic Family House in Abu Dhabi, UAE, and now continues as a Senior Religious Advisor.



Natan Sharansky – larissa.ruthman@gmail.com
Natan Sharansky became Chair of ISGAP in 2019.
Born in 1948 in Donetsk, Ukraine, he was a spokesman for the human rights movement, a prisoner of conscience and leader in the struggle for the right of Soviet Jews to immigrate to Israel. Sharansky was a founding member of the Helsinki Group, which monitored violations of international agreements of different religious and national groups in the Soviet Union. He worked closely with Andrei Sakharov, the renowned Soviet human rights activist, and kept close contact with foreign media beyond the iron curtain.

In 1977, a Soviet newspaper alleged that Sharansky was collaborating with the CIA. Despite denials from the US

government, Sharansky was found guilty and sentenced to thirteen years in prison, including solitary confinement and hard labor. He was released in 1986 and immigrated to Israel. In Israel, he became active in the integration of Soviet Jews and formed the Zionist Forum. He was the initiator and driving force of the historic rally for Soviet Jewry of over 250,000 people in Washington in 1987. In 1996, he established the Yisrael B'Aliyah party in order to accelerate the integration of new immigrants into Israeli society. He served in four successive Israeli governments as a Minister and Deputy Prime Minister.

In 2009, Sharansky was appointed Chairman of the Executive of the Jewish Agency for Israel. In 2018, he received the highest Israeli award—the Israel Prize—for promoting Aliyah and the ingathering of the exiles. Sharansky is the recipient of the Congressional Medal of Honor and the Presidential Medal of Freedom. He is the only living non-American citizen who is the recipient of these two highest American awards. In 2020, Sharansky was the recipient of the 2020 Genesis Prize. He is also the author of three books: Fear No Evil, The Case for Democracy, and Defending Identity.

He remains a champion of the right of all people to live in freedom and believes that the advancement of human rights is critical to peace and security around the world.

Dr. Charles Asher Small is founding Director and
President of the Institute for the Study of Global

Antisemitism and Policy (ISGAP) and is Director of the ISGAP-Woolf Institute Fellowship Training Programme in Critical Antisemitism Studies, Woolf Institute, Cambridge, UK. Small was recently appointed as a Research Fellow at St. Edmund's College, University of Cambridge and served as an Academic Visitor at St. Antony's College, University of Oxford. He was also a Koret Distinguished Fellow at the Hoover Institution, Stanford University.

Small received a BA in Political Science from McGill University, Montreal, a MSc in Urban Development Planning

in Economics, Development Planning Unit (DPU) from University College London; and a DPhil from St. Antony's College, Oxford University. He convened groundbreaking academic seminar series in the emerging field of contemporary antisemitism studies at Columbia University, Harvard University, McGill University, the Sorbonne and the CNRS, Paris, Stanford University, University of Miami and Yale University.

Small was the founding Director of the Yale Initiative for the Interdisciplinary Study of Antisemitism (YIISA), the first interdisciplinary research center on antisemitism at a North American university. He specializes in social and cultural theory, globalization and national identity, sociocultural policy, social movements and racism(s), including antisemitism(s).

Small is the author of books and articles including the six-volume *Global Antisemitism: A Crisis of Modernity* (Brill and ISGAP); *The Yale Papers: Antisemitism in Comparative Perspective* (ISGAP, 2015); *Antisemitism in Comparative Perspective: Volume Two and Three*, (ISGAP, 2016 and 2018); and *Social Theory—A Historical Analysis of Canadian Socio-cultural Policies Race and the Other* (Eleven International Publishers, 2013).

Small is committed to creating scholarly programming and research on contemporary antisemitism at top tier universities internationally, and establishing contemporary antisemitism studies as a recognized academic discipline. He is currently leading an international research project on the impact of soft power and undocumented funding on Higher Education as it pertains to antisemitism. Small also has a human rights advocacy background, including regarding the struggle for Soviet and Ethiopian Jewry, and was the Chair of the African National Congress Solidarity Committee, Canada.



His areas of focus are understanding the long term effects of psychological trauma, the applications of behavioral economics and game theory to psychiatry and forensic psychiatry.

He is the child of Holocaust survivors, which has been a key influence in every corner of his life, from becoming a healer focused on trauma to his political and philosophical commitments. As a child and young man he received a classic, old-world Yeshiva education (largely in Yiddish) with its emphasis on Talmud and ethical behavior. Later he was active in the Soviet Jewry movement and student support for Israel. These experiences of political activism have remained important to him throughout his life.

Amsel attended Yale School of Medicine followed by a psychiatry residency. Subsequently, he completed a MPH and joined the faculty of the Columbia University Medical School. There, for

a number of years following 9/11, he co-directed the clinic specifically funded to focus on victims of that terrorist attack. In this capacity he encountered a large number of police officers, firefighters and EMTs as well as financial professionals. This gave him an intimate and in-depth view of how trauma (in particular terrorism) affects people's political thinking as much as it does their emotions. It became clear to him that the aggregated traumatic response of a population has a very serious impact on the political attitudes and behaviors of the body politic.

Greenfield was also the recipient of the Haiti Jewish Refugee Legacy Project's 2012 Tikkun Olam Award for "shining a much-needed bright light on the dark seen and unseen world of anti-Semitism today."

In January 1980, *Ms. Magazine* cited Greenfield as a "woman to watch in the 80's." Featured in the national Jewish Women's Archive's "The Feminist Revolution" collection as among the women having had an influence on the women's movement, she walked out of the women's movement in 1983 in defiance of its embrace of antisemitism and illiberal dogmas.




Amira Halperin – amirahalperin336@gmail.com
Dr. Amira Halperin is an established scholar
specializing in refugees and media technology.
Halperin worked as an investigative broadcast
journalist for large media organizations, including BBC
Television and 'Panorama' programme, where she
investigated Islamist radicalization and terrorism.

Halperin is the first ever Israeli researcher who conducted research on the Palestinians in the diaspora. Her pioneering research of the Palestinian community in the UK was published in a book, *The Use of New Media by the Palestinian Diaspora in the United Kingdom* (Cambridge Scholars Publishing, 2018).

In the last decade, she has been working in Europe, North America, East Asia and the Middle East. During this period, she has been engaged in various projects in collaboration with government, NGOs and cybersecurity companies, and initiated many university community events (for example, a panel which was held at UBC with the White Helmets delegation to Canada).

Halperin is a collaborator with The University of British Columbia Centre for Migration Studies, Canada. She is a member of the steering committee of The Media of Diaspora Research Group, UK. 

Besides professional presentations and journal article publications, Mizrachi uses examples of looted books in talks with students and the public and is planning an exhibit of the material in the UCLA Library by the end of 2024. Other research interests and publications explore students' reading, library and information behaviors such as library anxiety and information literacy. Mizrachi conceived, coordinated and managed the Academic Reading Format International Study (ARFIS), the largest study to date on students' reading format (print and electronic) preferences and behaviors, gathering data from over 21,000 students in 33 countries. 





In 1969 he was awarded a PhD by the University of London's School of Oriental and African Studies (SOAS), on completion of his studies in its Department of History, chaired then by the eminent Professor Bernard Lewis. Shaked's doctoral thesis dealt with a unique manuscript biography of the Sudanese Mahdi.



Recognizing the urgency of combating antisemitism and fostering connections between Middle Eastern Christians and the Jewish community, Taimoorazy established the Assyrians Against Anti-Semitism initiative in 2018.

Deepening her involvement in advocacy, Taimoorazy serves as a member of the Simon Wiesenthal Midwest Region's Community Engagement Committee. Additionally, she was a fellow at The Witness Institute, an organization dedicated to upholding the legacy of Holocaust Survivor, Professor and Nobel Prize winner Elie Wiesel.

Currently pursuing her PhD at the University of Texas at Dallas, Taimoorazy continues to be an influential voice in addressing the challenges faced by persecuted communities in the Middle East and promoting unity in the face of hatred and discrimination.

Providence Nkurunziza is a child survivor of the 1994 genocide perpetrated against Tutsis in Rwanda. She is an author, speaker and advocate, as well as a Commissioner at the Texas Holocaust Genocide and Anti-Semitism Advisory Commission.

Five of her siblings and her two parents, along with the rest of her extended family members, were wiped out during the genocide against Tutsis in a span of about 100 days. She was 11. Next Couple Hours: A Story of Fear, Loss, Courage, and Determination During and After the Genocide Against Tutsis in Rwanda tells her story. More than a million innocentlives were claimed during this conflict, and as a survivor, Nkurunziza considers it her responsibility to bear witness to the atrocities of

genocide. She wants to save the next generation from falling into the same trap of experiencing such sinister events since nobody is immune to genocide.

She considers it a privilege to raise awareness of her loved ones, as well as all of those families, who were completely wiped out with no one to remember them. She does all with a thankful heart to preserve their memory and restore their values. She believes silence is complicity in the face of such atrocities and terror. As an advocate, she is also proud to be a voice for women survivors living with HIV/AIDS and other long-term illnesses contracted through rape and other violence during the genocide.

Her past speaking engagements have included: the United Nations Headquarters in Geneva, New York, and Vienna; the Swedish parliament; three of the four Holocaust museums in Texas, and many universities, libraries, churches and synagogues.


